#### CSS Becomes a CCBHC

## A new approach to health

In the fall of 2022, CSS was awarded a fouryear \$4 million grant by the Substance Abuse and Mental Health Services Administration (SAMHSA) allowing CSS to implement the Certified Community Behavioral Health Clinic (CCBHC) model for care delivery. CSS was one of only seven Ohio organizations to receive the grant.

The CCBHC model emphasizes coordinated, comprehensive, trauma-informed and recovery-oriented care for anyone in need of services for mental health or substance use.

regardless of ability to pay, place of residence or age. To achieve this, CSS has expanded its services to include treatment for children and adolescents, enhanced services for those with substance use disorder and increased outreach to certain populations that have been underserved. The grant provided funds to hire additional staff for these efforts, including a child and adolescent coordinator and crisis specialist; a care coordination specialist, and a cultural broker to assist with the needs of Nepali and other clients.

As a CCBHC, CSS must offer the following core services, either directly or through relationships with designated collaborating organizations:

- Targeted case management and care coordination.
- · Screening, assessment, diagnosis and risk assessment.
- · Patient-centered treatment planning.
- · Outpatient mental health and substance use disorder services.
- Outpatient primary care screening and monitoring.
- · Psychiatric rehabilitation services.
- · Peer and family support.
- Crisis mental health services.
- Intensive, community-based mental health care for veterans and service members.

CSS' collaborating partners include Child Guidance & Family Solutions, CHC Addiction Services and Portage Path Behavioral Health/ Psychiatric Emergency Services.

### Housing Support

## New facility offers housing for clients

In August of 2022, ground was broken for the Naomi Project supportive housing facility. Thanks to quick work by Tober Building Co., the facility was completed and opened just four months later, providing a new home for eight residents who were participants in CSS' Tent to House program.

The new facility, which was awarded funding through the Housing Tax Credit program, includes eight one-bedroom apartments and a clubhouse for the residents. It is one of 45 units of scattered-site supportive housing being developed in Summit County as New Frontier Homes, a collaboration between CSS, the City of Akron, Summit County Land Bank, Family & Community Services, Joanna House II and Tober Development Co. The goal of the new developments is to prevent or end homelessness for nearly 40 families in Summit County.

## Housing Retention

## Donor-funded position boosts housing success rate

Typically, about 50% of clients who are placed in housing lose their housing within the first six months, largely because of the lack of support. This fiscal year, that number changed for CSS, thanks to a newly created staff position.

Funding awarded by a generous local foundation enabled CSS to create a full-time housing retention specialist position. The retention specialist provides case management services to help ensure newly housed clients are successfully integrating into their housing and the community. The specialist also supports clients by helping them build coping skills to deal with feelings such as depression or anxiety that can arise from living independently or being in new situations.

Initially, the specialist contacts the clients several times a week and then tapers off visits over six months. In addition to case management, the specialist helps the client connect to an agency that will continue to provide support services.

Implementation of the housing-retention specialist position at CSS led to an incredible success rate: nearly 80% of clients now maintain their housing after six months. The success of the program has led the County of Summit Alcohol, Drug Addiction and Mental Health Board (ADM Board) to take over funding the position, which initially was funded for one year.

## Art of Recovery

# This year's event was the most successful yet for artists, CSS

Art of Recovery 2023, presented by Klein's Pharmacy, kicked off March 10 with an online auction of 45 professionally framed client-created works of art. On March 14, the live event returned to Akron Art Museum, celebrating the artistic expression of CSS clients and marking the most successful Art of Recovery yet.

Throughout the event, nearly 200 guests viewed and bid on the art, enjoyed hors d'oeuvres, engaged with the artists, learned more about CSS, and participated in a community art project celebrating resilience. The honorary chairs were Barry and Ann Klein, owners of Klein's Pharmacy and longtime CSS supporters.

It was an exceptionally successful night for the artists. Six of the 22 participating artists received awards for their works, as judged by two local artists. By the end of the night,


41 of the 45 pieces had sold - making it the bestselling Art of Recovery event for CSS client-artists. Seventy-five percent of the art sale proceeds went to the artists while the remaining 25% went to the CSS Expressive Arts Therapy program.

Thanks to Klein's Pharmacy and our other generous sponsors and supporters, the event was the most financially successful Art of Recovery to date.


